Treasurer's Report

Caveat: It was brought to my attention at the end of September that I had made a subtraction error of \$21.80 in my July report that carried over to my August and September reports so I've corrected that error by simply substracting \$21.80 from September's ending balance. Based on that disclosure, here's my Income/Expense report for September 2023. As of September 30, 2023 we had an account balance of \$7509.89 which includes \$1250 Prudent Reserve, \$1782.25 Speaker Meeting Funds and \$880.83 TF/CF Funds leaving an available cash

balance of \$3596.81. Besides our usual monthly bills, we spent \$189.25 for DCM travel to Area

Assembly, \$315.80 for Speaker Meeting speaker airfare, \$28.50 for PI/PCP pamphlets and printing, \$50 to Medford Alano Club for annual District Archives storage and \$21.80 to correct account balance. Our income included \$297 in group contributions, \$196.20 from Speaker Meeting 7th Tradition and \$152 from Speaker Meeting 50/50 raffle. Hopefully the Income/Expense spreadsheet will be posted in the chat along with the 2024 Proposed budget.

I am out of the country until 10/30/23 but will be in touch via email and WhatsApp. Thank you, Ellen, for presenting my report and the 2024 Proposed Budget for voting.
