women's jail report

The jail committee has 20 volunteers. Of those volunteers, an average of 3 women go into the jail to meet on the 2nd and 4th Wednesday of the month. The jail recently changed their form, and the clearance lasts an average of 2 years, so those women whose clearance was 2 years old found out the evening that they went in that they were no longer cleared - a lesson for me. I am now marking the date they were cleared so that the next person knows approximately when to get new clearance. No one of the volunteers who showed up the 2nd Wednesday had a current clearance, so we only had one meeting this month.

5.Treatment Facilities - Randy

District 16 Treatment Report 05/01/2025 Next District 16 Meeting 05/14/2025

- 1) District 16 has made the decision to fund Corrections/Treatment literature by way of the "White Cans" effectively putting the responsibility for literature on the white cans and outside the scope of the District 16 Budget. All funds are still going to District 16 and redirected to appropriate accounting line items. Let me know if your group is interested in a presentation on same.
- 2) Fresh Start Withdrawal Management, which is a detox center located in Medford is allowing us to go on Monday mornings, nothing formal, more like a meet and greet. In July, if all goes per plan, their new 20 bed facility will open. At which time we will be back in.
- 3) ARC, men's and women's residential treatment centers. Panel's go in on Wednesday at 1pm. Men and women allowed into men's facility with only women allowed into women's facility. Peg M coordinator for women's and Dee D for the men's facilities. Women's ARC is now allowing 2 women into the facility along with the lead. In addition, ARC women's is now allowing a panel on 2 nd Sunday of the month at 7pm. Kelly K has committed thru June, 2025.

Old Business: ADHOC Committee met on the 27th on zoom Randy reports he has been answering the phones as an experiment to see how many calls really need to be answered from the 2nd of April thru the 12th of May and that is what the report includes. Shifts were Monday thru Friday 4:00pm to 9:00am. The next shift was a long one 1200pm to 9:00am on Saturday until 9:00am on Monday The total number of calls was 25 but 3 of them look like it was the volunteers switching the calls over to the other volunteers. If you volunteer to do this service your personnel phone number is not shown to the individual calling in for help. There was 1 call on Monday one on Tuesday 5 on Wednesday 7 on Thursday 3 on Friday and 8 on Saturday. Randy said life continued for those answering the phone. So this was using the phone service from Spectrum. The volunteer transferred the phone when closing up the Central Office for the night and it went to Randy.

Conclusion: The value of the answer page which is what we currently use is unreasonable. We recommend using the Spectum Service we now have using AA people answering the phone calls. So if the GSR's can take this back to their groups and see if people are available to volunteer we need to know and that is our next step. Monthly savings per month is approximately \$120.00 to the District as Central Office will take over with much lower charges following the 3-6 month set up period. If we just use the Spectrum Phone Service and transfer the phone to the daily volunteer. We also need the District to commit to at least 3-6 months so we have the time to get the new service up and running. We also believe we should have a volunteer workshop so when we get the new program going everyone of the volunteers is comfortable in knowing how it will all work and what is required of them.

Terry asked so what we want to know now is are there volunteers wanting to help.

Kelly answered we want the hand of AA to always be there but we need to know there are people willing.

Lori asked if we do this, are we going to eliminate that \$ something dollar service fee altogether.

Kelly Yes

GSR's were asked to take this option back to their Home Groups to see what kind of response they get with people being willing to volunteer for the phone service.

New Business:

We use a modified Robert's Rules of order so if the motion is not seconded it will not go any further.

Wayne T. submitted a verbal motion to create a District 16 Chair Safety & Inclusion Chair position.

The intent of this motion is to create a District Chair position in D16 to connect the District with the Area 58 Safety and Inclusion (IS) Committee. The purpose is to access the SI Committee's support and resources to help groups reach an informed group conscience regarding safety issues. Wayne further shared the guidelines.

Lori seconded the motion.

The motion was opened for discussion:

Mollie shared strong support for the motion and her experience with S&I issues.

Jillian pointed out the number of current open positions and that this position might fall under Access Committee

Kathleen pointed out there are currently 7 positions open

Terry supported Jillian's position but focused more on doing active recruitment for the open positions. Maybe offering 2 S&I Workshops per year. Maybe having Co-Chairs of Access and S & I

Mollie feels recruitment is a separate issue but again strongly supports S & I

Kelly recommended a change in structure to include Access Chair

Laura supports having S & I arm of Access Committee

Discussion ended with a question being called.
